Minutes of an Ordinary meeting of South Milford Parish Council at Grove House, Grove Crescent, South Milford 7.00pm on 6<sup>th</sup> December 2022

# 1. Apologies and welcome all Councillors

Attending: Cllr Gore, Gigg, Shaw, Brooksbank & Waters Apologies: Cllr Grogan, Diamond, McAleese and the clerk

#### 2. Declarations of Disclosure Pecuniary and Other Interests

Cllr Shaw declared an interest in a planning matter.

# 3. To approve Minutes from the Monthly Ordinary Meeting held on Tuesday 15<sup>th</sup> November 2022

Proposed Cllr Gigg, seconded Cllr Brooksbank, all agreed.

## 4. Items for consideration and discussion - with proposals and votes where relevant

• **Precept** – discuss and agree level of precept for 23-24.

After discussion it was proposed by Cllr Shaw to go with £25.57 pa (for a Band D property), increased from £23.18 per household, a 10% increase. The increase reflects the current high levels of inflation (noting that many of the council's costs are inflation linked) and the small or nil increases in precept levels in recent years. The total amount to be collected for 2023/24 will be around £27,249. The proposal was seconded by Cllr Brooksbank, other councillors agreed excluding Cllr Waters who abstained (due to lack of information regarding overall financial position). Clerk to inform SDC.

# • Warm hub - updates and agree Parish Council funding

Cllr Waters has written to funding schemes for advice and money. Questions were asked about the cooker and microwave as neither are in working order. Cllr Gigg to ask Drew Fussey of SDC if they can replace and also organise updated PAT testing. Parish Council would be prepared to offer some funding for new appliances but agreed that the SDC angle should be explored first.

It was proposed to print leaflets to advertise the Warm Hub - proposed Cllr Gore, seconded Cllr Brooksbank, all agreed.

It was noted that the councillors, volunteers and visitors attending the warm hub are covered by the PC's liability insurance policy, however the building itself should be covered by SDC policy.
