2020/0779/FUL Demolition of existing dwelling and erection of 4 dwellings 16 Low Street, South Milford - The Parish Council has no objections but our previous comments on inserting a condition that plots to rear of site should not be allowed to convert to 3 storey dwellings in the future.

2020/0521/REM Reserved matters application including access, appearance, landscaping, layout and scale of approval 2018/1141/OUT demolition of existing buildings and erection of a residential development comprising o 7 no dwellings and associated garage/parking 25 Sand Lane, South Milford – Note that contrary to the description, the updated plans are for 3 detached dwellings and the Parish Council has no objections.
