- 3. To approve Minutes from the Monthly Ordinary Meeting held on 31st January 2023 proposed Cllr Water, seconded Cllr Gigg, all agreed
- **4.** Data from Flashing Traffic Sign, South Milford update from Georgina Ashton a slide show was shown to the Councillors and an explanation how this works. Someone needs to move and collect the data regularly. This information is sufficient to pass onto the Police to monitor speed in this area. The Chair thanked Georgina for her efforts on behalf of the Council.
- 5. Items for consideration and discussion with proposals and votes where relevant
 - PLANET request for donation towards planning consultant fee in connection with the travellers' site and the limestone quarry application. It was agreed that the PC should have been asked to be involved at an earlier stage and can't provide financial support on this occasion. The PC appreciated all the group's efforts and the Clerk would share this message with Doug Fletcher.
 - Footpaths Cllr Waters update plus emails received from residents re: Redhill Lane (under motorway), Well Lane to Mill Lane path (near Mutleys) and reinstating roadside footpath on Common Lane. Cllr Waters provided updates and confirmed that a meeting with NYC was scheduled for early May. It was agreed the Clerk would contact the farmer about the footpath over the field near Steeton Hall and Cllr Gigg would add onto the NYCC portal the overgrown / covered up footpath alongside Common Lane (Cllr Waters has already raised this via NYCC webpage).
 - Allotments Cllr Shaw update SDC grant of £3k is due shortly Cllr Shaw updated the PC on costs and funding already sourced. It was agreed that the PC would allocate some funds, including remaining CIL money, towards the allotments. A separate meeting will be held on the 13th April to discuss the allotments, and agree funding, in detail. Clerk to inform the farmer Tony to not put is cattle back onto the field.
 - Football club / Swan Craft update on recent correspondence / meetings note email received from coach of one of junior teams A update discussion took place, we the Parish Council again noting its frustration with the current situation. A specific Swancroft / football meeting will be scheduled in early
