### • Requests for Funding

- Year 6 leavers party Cllr Gore proposed £10 per child (as in prior years), seconded Cllr McAleese, all agreed.

### • Footpaths

- Partial blockage of footpath from Mill Lane to the railway lane Cllr McAleese to meet with Richard and Stephen Batty to discuss.
- Update and next steps on the proposed closure of the footpath from the bypass to Nordens Barn Farm - Parish Council objected, this is likely to go to the Secretary of State for a decision.
- Any updates for discussion the Clerk to contact Liam to remove the fallen ivy on the footpath from Westfield Lane to High Street.
- Xmas lights
  - Residents vote for favourite during December results and decide next steps Cllr Gore has put together a spreadsheet with the results. The plan is to retain about half the lights, unless sponsors come forward to fund more. Clerk to ring Leeds Light to ask when they are to be taken down and discuss collection etc.
- Allotments
  - A discussion was held about the parking. The parking area on the allotment site has suffered considerable due to the weather, and it currently unusable. Cllr Shaw to contact the farmer direct if any further problems with parking on the access road, noting that allotment holders are aware that they should not do this.
  - Planning moving forward with the help of a Planning Consultant.
  - Cllr Shaw has successfully received a National Lottery grant for the allotments. This will cover costs for toilet, community shed, CCTV and the orchard.
- Grasscutting
  - Updated maps and tender for services for 2024 this will go out to tender in the next week. Clerk to ask neighbouring PC's who they use.
