Minutes of an Ordinary meeting of South Milford Parish Council at Grove House, Grove Crescent, South Milford 7.30pm on 21st November 2023

Proposed Cllr Shaw seconded Cllr Grogan – all agreed

- 4. Items for consideration and discussion with proposals and votes where relevant
 - Council's financial position (present funds and BAU income/outgo), to aid discussion and decisions regarding:
 - O Possible funding for South Milford Against Flooding's proposed bund Derek handed out a list of all current costings for the proposed bund and explained each one. They are a large amount short, even allowing for the already promised £12,000 from the Parish Council. It was agreed that the group should continue to seek grant funding, contributions from other organisations (in particular NYC and Yorkshire Water) and fundraising to cover the shortfall. However, given the importance of the project, the Parish Council agreed it would add an additional £5k to the precept this year, to ensure that the project can go ahead in 2024. Proposed Cllr Shaw, seconded Cllr Brooksbank, all agreed. The Chair thanked Derek for all is efforts in this matter.
 - o The level of our Precept for 2024/25 decision required by 31st December 2023 after discussion, and factoring in the above, it was agreed to go with £31,445 for 2024/5 precept. This is an increase of 15% about half of this increase is to cover inflationary increases in costs, with the other half being the one-off increase to cover the addition costs of the bund. The expectation is that this one-off amount would be excluded from the precept in future years,leading to a possible reduction in precept in 2025/6 (subject to inflationary pressures and any other funding needs). This was proposed Cllr Shaw, seconded Cllr Brooksbank, and all agreed.
 - Request for funding from Sherburn Visitor Scheme more information is needed how many residents from South Milford actual used the facilities and what donations others PC's make?
 - Request for War memorial Lumby more information is needed before a decision can be made.
